EXCHANGE SERVICE

DIRECTIONS FOR USING THE TELEPHONE

Consult the Directory before placing a call, and ascertain the number wanted.

To call the Operator remove the Telephone from the hook, and hold it to the ear. When the Operator answers "number," respond promptly by giving the number of the Subscriber's station required, giving the figures of the number separately, as "One-four-two-nine," instead of "fourteen-twenty-nine." Keep the Telephone to your ear and the Operator will connect you with the party called for and ring his bell, unless his line is found to be busy, in which case she will notify you of that fact.

Do not hang up your receiver until you have finished talking.

When you have finished talking place the receiver on the hook and wait ten seconds before calling another number. This gives the Operator time to disconnect the previous connection.

Answer the calls on your bell promptly.

Face the Transmitter with the mouth half-an-inch from the opening. Speak naturally, distinctly, and not too rapidly.

Call "Information" for subscribers or changes not found in this Directory. Do not use the Telephone during a thunderstorm.

RULES AND REGULATIONS.

Destroy previous lists.

The right of the subscriber is to use the instruments and connecting lines under such rules as the Government may from time to time prescribe. He shall not extend their use to other individuals, except his servants upon his business, nor shall they be used for any tolls or consideration to be paid by any person other than the Subscriber; nor does this confer on him the right to use any other instrument. There are Public Pay Stations installed at convenient locations for the accommodation of non-subscribers and the general public.

A Subscriber is not allowed to remove or otherwise interfere with the wire connections or parts of any Telephone apparatus leased.

Moving of Instruments.—The Telephone is first located where the Subscriber directs; if, afterwards, the instrument is required to be moved, such removal will be done at the expense of the Subscriber. Local Manager should be notified ten days in advance.

Numbers.—Subscribers are requested not to advertise Telephone Numbers, but simply the word "Telephone," as it may be necessary to change such Numbers.

The use of profane or improper language over the line is strictly forbidden.

Complaints regarding ~~inattention on the part of employees, or of interruptions to Exchange service,~~ should be made to the **Trouble Department Telephone**, which in the larger Exchanges is given at the head of the list of subscribers for that place, and, if not properly attended to, to the Agent or Local Manager. If the matter is not then satisfactorily arranged, notice should be sent to **Head Office, Edmonton.**

Long Distance Service

RULES AND REGULATIONS.

To Make a Long Distance Call.—First call for “Long Distance.” When the Long Distance Operator answers, give the number or firm name, the initials and name of the particular person desired, the city or town, and the initials and name of the person originating the call.

Long Distance Charges.—All rates quoted are for an initial period of three minutes. For overtime beyond the initial period charge will be made by the minute.

Where messenger has to be sent, initial toll rate must be paid in addition to messenger service, if party calling does not wait one hour for connection. If delay exceeds one hour, call may be cancelled on payment of messenger service charges.

When a particular person is desired, the name must be given to the Operator, otherwise charge will be made from the time of connection established with the Telephone desired, whether the party required is obtained or not.

Non-subscribers who desire the use of subscribers' telephones should be referred to the nearest Public Pay Station.

Night Rates.—From 6 p.m. to 6 a.m., a night rate of about one-half the day rate, is in effect over the Long Distance lines of the Government. In no case is the night rate to be less than 25 cents, unless the day rate is less, in which case the night and day rates will be the same.

Reversal of Charges.—All charges will be made against the originating office except those messages for which the receiving party expressly agrees to pay. The assent of the receiving party to a reversal charge must be obtained before the connection is established.

Messenger Service.—Upon request, and the prepayment of reasonable charges a messenger will be sent when possible to notify a non-subscriber to come to any Public Pay Station.

Complaints regarding unsatisfactory Long Distance Traffic should be made direct to Head Office, Edmonton.

What "LINE BUSY" Means

It is easier for an operator to establish a connection than reply "Line busy." Recollection of this simple fact may perhaps smooth out the asperities of a state of mind evoked by a hasty conclusion that the operator simply is shirking. Follow a call into the main exchange, for example. You ask for a certain number. The operator immediately informs you the line is busy. How does she know? Simply by a little admonitory click in the receiver when she tried to "plug in" on the line asked for. She cannot tell you who is talking on the line, how long it has been in use, or how long it is likely to be "busy." All the information she possesses is a "click," but it is sufficient to advise her that some one of the 150 other operators in the exchange had a prior call from or to that number. Had the line been clear, the effort to complete the connection would have been no greater than that required to get the "click;" hence, the task of informing a caller that the line is busy is just so much extra labor—in fact, it involves a double burden, as the subscriber will usually repeat the call until he is able to transact his business. Obviously, therefore, the desire of the operator is to establish the connection when it is first called for. She has no motive in doing otherwise.—From "Telephone Talk."
